Superintendent Search School and Community Profile

The Franklin County Community School Corporation is seeking qualified applicants for the position of Superintendent. The successful candidate will begin duties on July 1, 2024. Franklin County Community School Corporation

Franklin County Community School Corporation consists of five schools serving 1,987 students in grades PreK – 12. Schools include:

Brookville Elementary (K - 5) - 485 students

Laurel School (PreK – 6) – 264 students

Mt. Carmel School (K – 6) – 224 students

Franklin County Middle School (6 – 8) – 364 students

Franklin County High School (9 – 12) – 650 students

The Franklin County Community School Corporation takes pride in its curricular, co-curricular and extracurricular programs. Achievements and areas to note include:



- 98% High School graduation rate.
- Ability to earn an associate's degree by graduation. In the 2024-25 school year, it is projected that 24 associate's degree will be earned.
- Largest offering of dual credit opportunities in the region. In the 2022-23 school year, 273 students earned 2,441 dual credits, saving \$415,141 in future college costs.
- 85 seniors in the 2023-24 school year (approximately half of the graduating class) have been involved in internships. 100 area businesses agreed to be part of the internship program.
- A music program that offers unique opportunities unmatched in the region. Students have access to a comprehensive curriculum that includes band, choir, guitar, piano, music theory, music history and music technology. Students have access to a new music graduation pathway.
- A full offering of co-curricular and extra-curricular opportunities for children across all grade levels.

The Franklin County Community School Corporation is located in southeastern Indiana. The school corporation's district office sits in the town of Brookville. The school community is tight-knit and as a result takes a great deal of pride in the school corporation. The school corporation encompasses 300 square miles of Franklin County. When school is in session, 63 school buses travel approximately 2700 miles each day to transport students to and from school.

Students in the Franklin County Community School Corporation has access to career and technical programs through the Whitewater Technical Career Center. Students with special academic programming needs have access to additional services through East Central Special Services.

Franklin County Community School Corporation is one of the largest employers in the county. The vast majority of these school employees have chosen Franklin County as their home.
