The Mitchell Community School Corporation is seeking its next superintendent. The successful candidate will assume the role from interim superintendent, Dr. Steve Phillips. The Indiana School Boards Association Director of Board Services, Steve Horton is assisting the Board of Trustees with the search.

The Corporation

MCS is located in Mitchell Indiana in Lawrence County south of Bloomington and the Indiana University campus. The corporation is comprised of two elementary schools, Burris Elementary and Hatfield Elementary, and Mitchell Junior and Senior High Schools. The four facilities serve more than 1,400 students K -12.

The Corporation has taken pride in its strong academic performance. Early literature and technology are a focus for teaching and learning. The learning extends beyond the academic opportunities for the students. The student experience also includes varied educational opportunities, focusing on academic skills, creative talent, social skills, and character development.

As the students transition into junior and senior high school, they are exposed to learning pathways in various career and technical fields including:

- Advanced Manufacturing
- Agi-Science and horticulture
- Biotechnology
- Construction Trades
- Culinary Arts
- Health Science: Pre-Nursing and Healthcare Specialist



The corporation remains committed to preparing students for

life beyond their high school graduation. Academically, students have the opportunity to enroll in AP and College Credit courses to give them an important head start in a higher education degree program.

Many special interest clubs, music, art and athletic opportunities exist to allow all students to pursue their interests and grow personally beyond academics.

An important partnership for MCS is COSMOS, Collaboration of Shoals, Mitchell, and Orleans Schools. This collaboration allows course offerings and learning pathways to grow continuously.

Higher education opportunities include nearby Indiana University, Ivy Tech Community College - Bedford, and Oakland City University in Bedford Indiana.
