Lake Ridge New Tech Schools consists of three schools (Calumet New Tech High School, Lake Ridge New Tech Middle School, and Longfellow New Tech Elementary School) serving approximately 1,550 students in grades K -12. The corporation also serves Pre-K students in the Lake Ridge Head Start Program that serves 122 children ages 3 – 5 in both full-day and part-day model options.



Lake Ridge New Tech Schools is proud of the many academic, cocurricular and extracurricular programs it offers to students. A sampling of those include:

- All schools in the district (Grades K 12) have New Tech designations with a vibrant, relevant, and rigorous curriculum
- A \$20 million renovation scheduled to be completed in November 2025, which includes a state-ofthe-art auditorium as well as a fieldhouse that will support curricular, co-curricular, and extracurricular school and community activities
- A strong visual and performing arts program with over 100 participants district wide
- An open enrollment policy that attracts students from neighboring districts

Lake Ridge New Tech Schools is located in Lake County, Indiana. The district serves students in Calumet township as well as portions of Gary. The district sits approximately 35 miles from the heart of downtown Chicago. Residents of the school community enjoy a smaller town environment while also being able to take of advantage of all that the City of Chicago has to offer. Residents also take full advantage of the recreational opportunities afforded to them by proximity to Lake Michigan and parks in the tri-state area. The district also sits approximately 150 miles northwest of Indianapolis.

The major economic driver in the school community is the steel mills. There is a rich tradition of dedication and hard work by residents in the industry that promote a strong sense of pride for generations. The Hard Rock Casino also serves as a large employer in the school community and promotes tourism to the area.
